



Polish Presidency's operation "DEMETER" - information.

Date of the operation

Operation DEMETER is scheduled for the period from 24 to 30 October 2011

Place of the operation

The territories of the EU MS, who will be willing to participate in the operation.

Operation objective

Operation DEMETER will be the continuation of HERMES (BEL) and MITRAS (HUN) operations which were carried out by these Member States in the course of their EU Presidencies in the second half of 2010 and first half of 2011. The Polish Presidency sees the merits in continuing these operations in the second half of 2011.

Polish Presidency invites all EU Member States and Schengen Associated States to participate in the DEMETER operation

The aim of the DEMETER operation will be to collect information on migration flows in

EU Member States, regarding in particular:

- migratory pressures in various countries,
- the main routes of movement of illegal migrants;
- the main target countries of migration;
- illegal migrants' countries of origin,
- places of detection of illegal migrants (border crossing points, outside of border crossing points, MS territories) and means of transport which were used by illegal migrants (cars / buses, trains, ships, aircraft),

DEMETER operation will be extended to airports.

The report templates to be used during the DEMETER operation shall be similar to those used in the operations HERMES and MITRAS, with the sole extension to an illegal immigrants' apprehension/ detection place (border crossing point, outside border crossing points and MS territory).

Contact details of the responsible authority in POL

The **institution responsible** for conducting the operation is the Polish Border Guard Headquarters. The contact point of the operation will be placed in the Polish Border Guard Commanding Centre.

EU Member States submissions

EU MS who would like to participate in the operation, should send information about the national

coordinators by 10 October 2011 at the latest to the POL DEMETER contact point via email

ncp.warszawa@strazgraniczna.pl.

How to fill in the reports:

1. Information about each detected event/incident should be included in a separate report. In case of detention of two or more illegal migrants it will be allowed to place the data in one

report, provided that all the details of their detention are identical.

2. Citizenship of migrants should be determined by the ISO code (Alpha-3). Example:

Ukraine - UKR, Bangladesh - BGD, China-CHN. Full list of codes is available on the

website http://en.wikipedia.org/wiki/ISO 3166-1

3. Reports should be completed in English, using capital letters.

In relation to the name of the location of the apprehension of the migrant the use of mother

tongue will be approved. It will be also permitted to use proper names.

4. In order to determine the date and place of the entry by the migrant to the EU territory all

available sources of information should be used, with particular emphasis on IT systems and databases to which the services responsible for apprehension have access. As a last resort,

you can also rely on the arrested migrant's statement made during the hearing.

5. In case of the a route countries through which detained was going to move or was

apprehended should be also indicated. ISO (Alpha-3) codes should be used to determine the

country. Subsequent grids will be used appropriately for:

first, second and third - to indicate the last three States through which the detained

was moving before crossing the border to a country where the apprehension took place.

For example: CHN-RUS-UKR-POL

fourth (the middle) always refers to the country in which the apprehension took place,

fifth, sixth and seventh are used to determine the next three countries to which the

detained planned to move before he was apprehended.

For example: **POL**-DEU-NLD-BEL

The entire record will therefore look as follows: CHN-RUS-UKR-POL-DEU-NLD-BEL

In the case where the target state of illegal migration is the state in which the apprehension took place, grids 5, 6 and 7 should remain blank.

For example: CHN-RUS-UKR-**POL**- - X

- 6. Each report should be given a unique, consecutive number. The numbering of reports on successive days, must be continuous.
- 7. In the case of a need to send additional information about the selected event or in a case of changing the content of the report the report must be sent again. It will be replaced.
- 8. Reports can be sent in one file or in separate files.
- 9. Reports should be sent in a format established by the Polish Presidency. A file containing the model of the report will be sent to national coordinators after 10 October 2011

Sending of the reports:

- Reports will be sent electronically to the POL DEMETER operation contact point to the address: ncp.warszawa@strazgraniczna.pl.
- Reports should be sent after the end of each day, at the latest on 13h00 of the next day.
- The first report should be sent 25 October 2011 (information about 24 October 2011), and the last report on 31 October 2011 (information about 28, 29 and 30 October 2011).

Operation summary and the conclusions:

- After the operation, MS which participated in the operation will send to the POL DEMETER operation contact point a short report summarizing the operation. The Presidency attaches great importance to include into those reports the information regarding decisions taken in respect of apprehended illegal migrants (whether they were released, their detention in centers for foreigners, transferred to other States or removed to their country of origin). Those reports should be sent to the POL DEMETER operation contact point at least by 10 November 2011.

POL DEMETER operation contact point will prepare a report summarizing the DEMETER operation which will be sent to all countries participating in the operation to 30 November 2011

The summary of the operation will take place at Frontiers Working Party meeting on 07 December 2011.
